#### **COURSE OBJECTIVE**

This course is designed to cover different aspects of data analytics using the Python programming language environment and packages. In this course you will learn how to use Python to do data manipulation, visualization, conduct tests, build, validate and evaluate statistical learning models. The course provides hands-on experience and you and you will learn the concepts by working on datasets from different resources and using Python to produce insight that can be used to make better data-driven business decisions. The course is offered in-person in Fall 2021.

#### **COURSE DESCRIPTION**

This course is a hands-on learning experience to learn about different techniques use in data analytics using Python. Python has become one of the most important tools used by practitioners to perform data analysis and analytics tasks. We will learn required aspects of using Python for different aspects of an analytics project. This includes data manipulation and wrangling, visualization, statistical inference and inferential data analysis, statistical learning methods for different scenarios, etc. We will also learn about how models could be evaluated and how models can be used to help the decision maker make better data-driven decisions. We will use various relevant packages that are popular in the Python data analytics world.

#### **LEARNING OUTCOMES**

Upon completion of this course, students will be able to complete the following key tasks:

- > Conduct basic data manipulation and data wrangling in Jupyter Notebooks
- Create advanced visualizations using Python for different types of data and variables. Improving visualizations for both categorical and numerical variables.
- > Create exploratory analytics reports based on data.
- Use Python to conduct advanced statical inferences. This includes preparing the dataset so that statistical tests can be conducted.
- Learn about different supervised and unsupervised statistical learning methods. Learn different scenarios appropriate for each method and learn about the evaluation techniques used in each method.
- Build, validate and evaluate different supervised learning models and apply them to datasets to produce data-driven intelligence.
- Learn about different techniques common to data cleaning and pre-processing. This includes data transformation and variable encoding.

## **Course Deliverables**

#### In-class quizzes (10%)

These in-class quizzes are worth 10% of your overall mark. An in-class quiz will include questions on the material discussed up to that session in the course. The quiz takes place during the lecture. In-class quizzes are individual. There will be three in-class quizzes during lectures in weeks 5, 9 and 12.

#### Midterm Exam (30%)

Midterm exam is mandatory and takes place during a session. You will be able to use your notes from the class. Midterm exam is individual. The exam is tentatively scheduled for October 29 during class time.

#### Final Exam (40%)

Final exam is mandatory and will be schedule by the Office of Registrar. You will be able to use your notes from the class and the textbook. Final exam is individual.

#### Group Project (20%)

In this project, you will apply many of the topics learned in class to one or several datasets to conduct different tasks, build and evaluate models and produce insight. The project is a group work, and all group members will be receiving the same mark. The project may involve other aspects (research, etc.) as well. The details of the requirements for the group project will be announced in class.

### MISSED ACADEMIC WORK

## Missed Mid-Term Examinations / Tests / Class Participation

Where students miss a regularly scheduled mid-term or class participation for legitimate reasons as determined by the Student Experience – Academic (MBA) office, the weight for that test/participation will be distributed across other evaluative components of the course at the discretion of the instructor. Documentation explaining such an absence must be provided to the Student Experience – Academic (MBA) office within five (5) working days upon returning to school.

To document absences for health related reasons, please provide to Student Experience – Academic (MBA) office the Petition for Relief for MBA Missed Term Work and the McMaster University Student Health Certificate which can be found on the DeGroote website at http://mbastudent.degroote.mcmaster.ca/forms-and-applications/. Please do not use the online McMaster Student Absence Form as this is for Undergraduate students only. University policy states that a student may submit a maximum of three (3) medical certificates per year after which the student must meet with the Director of the program.

To document absences for reasons other than health related, please provide Student Experience – Academic (MBA) office the Petition for Relief for MBA Missed Term Work and documentation supporting the reason for the absence.

Students unable to write a mid-term at the posted exam time due to the following reasons: religious; work-related (for part-time students only); representing university at an academic or varsity athletic event; conflicts between two overlapping scheduled mid-term exams; or other extenuating circumstances, have the option of applying for special exam arrangements. Such requests must be made to the Student Experience – Academic (MBA) office at least ten (10) working days before the scheduled exam along with acceptable documentation. Instructors cannot themselves allow students to unofficially write make-up exams/tests. Adjudication of the request must be handled by Student Experience – Academic (MBA).

If a mid-term exam is missed without a valid reason, students will receive a grade of zero (0) for that component.

### Missed Final Examinations

A student who misses a final examination without good reason will receive a mark of 0 on the examination.

All applications for deferred and special examination arrangements must be made to the Student Experience – Academic (MBA) office. Failure to meet the stated deadlines may result in the denial of these arrangements. Deferred examination privileges, if granted, must be satisfied during the examination period at the end of the following term. There will be one common sitting for all deferred exams.

Failure to write an approved deferred examination at the pre-scheduled time will result in a failure for that examination, except in the case of exceptional circumstances where documentation has been provided and approved. Upon approval, no credit will be given for the course, and the notation N.C. (no credit) will be placed on the student's transcript. Students receiving no credit for a required course must repeat the course. Optional or





elective courses for which no credit is given may be repeated or replaced with another course of equal credit value.

Requests for a second deferral or rescheduling of a deferred examination will not be considered.

Any student who is unable to write a final examination because of illness is required to submit the Application for Deferred MBA Final Examination and a statement from a doctor certifying illness on the date of the examination. The Application for Deferred MBA Final Examination and the McMaster University Student Health Certificate can be found on the DeGroote website at http://mbastudent.degroote.mcmaster.ca/forms-and-applications/ Please do not use the online McMaster Student Absence Form as this is for Undergraduate students only. Students who write examinations while ill will not be given special consideration after the fact.

In such cases, the request for a deferred examination privilege must be made in writing to the Student Experience – Academic (MBA) office within five business days of the missed examination.

Special examination arrangements may be made for students unable to write at the posted exam time due to compelling reasons (for example religious, or for part-time students only, work-related reasons):

- Students who have religious obligations which make it impossible to write examinations at the times posted are required to produce a letter from their religious leader stating that they are unable to be present owing to a religious obligation.
- Part-time students who have business commitments which make it impossible to write examinations at the times posted are required to produce a letter on company letterhead from the student's immediate supervisor stating that they are unable to be present owing to a specific job commitment.

In such cases, applications must be made in writing to the Student Experience – Academic (MBA) office at least ten business days before the scheduled examination date and acceptable documentation must be supplied.

If a student is representing the University at an academic or athletic event and is available at an overlapping scheduled time of the test/examination, the student may write the test/examination at an approved location with an approved invigilator, as determined by the Student Experience – Academic (MBA) office.

In such cases, the request for a deferred examination privilege must be made in writing to the Student Experience – Academic (MBA) office within ten business days of the end of the examination period.

Note: A fee of \$50 will be charged for a deferred exam written on campus and a fee of \$100 for deferred exams written elsewhere. In cases where the student's standing is in doubt, the Graduate Admissions and Study Committee may require that the student with one or more deferred examination privileges refrain from reregistering until the examination(s) have been cleared.

### ACADEMIC ACCOMMODATION FOR STUDENTS WITH DISABILITIES

Student Accessibility Services (SAS) offers various support services for students with disabilities. Students are required to inform SAS of accommodation needs for course work at the outset of term. Students must forward a





copy of such SAS accommodation to the instructor normally, within the first three (3) weeks of classes by setting up an appointment with the instructor.
